**APPROVAL OF MINUTES: Motion was made by Ron West to approve minutes from March 9, 2020 meeting.** Brian Baird seconded the motion and minutes were approved. This was voted on and passed unanimously.

## TREASURER'S REPORT: Pat Sherman

# **DIRECTOR'S REPORT: Jessie Biggerman**

Jessie informed the Board that we are waiting on the rest of our PPE to arrive and hope to open up next week. She reviewed the new protocols that the District has put in place to keep the employees and community safe. She reviewed that we are looking at having appointments for Creative Resources to help with the 6 feet distance requirement.

Jessie discussed the plan on opening the Edinburgh location. She reviewed the policies we have set up to help keep staff and the community safe. She also spoke about having our staff from Franklin assist in the opening of the site and education. We are hoping to open the Edinburgh site the week after we open the Recycling Center.

Jessie spoke about the Tox Box. She informed the Board that we knew we would have to change our process at the Tox Box. We are going to be starting with Saturday, May 30, 2020 at our office by appointment only. We will allow 100 people with 25 per hour. Then June 15, 2020 we will open up the Tox Box at its location pending availability of the restroom space. We will be open the usual Monday, Wednesday and Friday this will be by appointment only with the slots being 15 minutes.

Mayor Myers had to leave the meeting.

## **LEGAL REPORT: Lynn Gray**

Ms. Gray reviewed the Interlocal Agreement between the town of Edinburgh and the Johnson County Solid Waste Management District. Motion was made by Ron West to approve the Interlocal Agreement between the town of Edinburgh and the Johnson County Solid Waste Management District along with having Vice Chairman Kevin Walls act as the designated signer of the Agreement. Lynn also stated that we need to be keeping our Covid expenses separate from all other expenses. This will help with submitting expenses if we can qualify for reimbursement.
