ELECTION OF OFFICERS:

Chairman Kevin Walls asked for a motion to elect officers to the Johnson County Solid Waste Management District Board for 2024. **David Lekse made a motion to have, Chairman Kevin Walls, Vice Chairman Mark Myers, and Ron West as Secretary.** Motion seconded by Mark Myers and approved. Motion passed with a unanimous vote.

APPROVAL OF MINUTES: David Lekse made motion to approve minutes from November 6, 2023, meeting. Mark Myers seconded. Motion passed with a unanimous vote.

TREASURER'S REPORT: Angela Coy

Approval of the check register dated November 7 to December 31, 2023, **Mark Myers made a motion to approve check registers, auto pay deductions, and claims.** Ron West seconded. Motion passed with a unanimous vote.

Approval of the check register dated January 1 to January 8, 2024. **David Lekse made a motion to approve check registers, auto pay deductions, and claims.** Mark Myers seconded. Motion passed with a unanimous vote.

Jessie informed the Board that the CAC met in November for the Pitch in and will meet again in February. They are planning to do something for Earth Day. The CAC is wanting to do an eclipse project.

DIRECTOR'S REPORT: Jessie Biggerman

Jessie updated the Board on the staffing situation at the Recycling Center. She reviewed with the Board the volume of cardboard recycled. She explained that a volume of 15,000 pounds of cardboard was collected in a seven-day period. She also informed them where the District is with Spring programming. We are also working with the MS4 and taking part in hosting a program with the JCWQP. The program is to be at the Johnson County Museum.

LEGAL REPORT: Lynn Gray
